Seminar Tasks for Joint Action (PH359)

All works cited are listed in the final section, 'References'.

Week 2

Write and bring a short (<501 words) critical review of Searle (1990). Send it to your counterpart and to the lecturer.

Read your counterpart's critical review and formulate a question to ask her in the seminar. (Or, better: meet your counterpart to discuss your critical reviews before the seminar.)

Week 3

Right half: write and bring a short (<1,501 words) critical review of Bratman's account of shared agency. Also send this to your counterpart for peer review, and send it to the lecturer.

Left half: Write a peer review of your counterpart's essay. Bring it to the seminar and send it to your counterpart and the lecturer.

Reading: EITHER Chapters 1-4 of Bratman's book (Bratman 2014) (available online through the library); or the sequence of papers Bratman (1992), Bratman (1993), Bratman (1997), Bratman (2009). If short of time just read Bratman (1993)
